PREVENTATIVE BENEFITS: COLONOSCOPIES, WHAT IS COVERED?

Routine Screening

Alliant considers any of the following colorectal screening tests medically necessary preventative services for members beginning at age 50:

- Sigmoidoscopy (considered medically necessary every 5 years)
- Double contrast barium enema (DCBE) (considered medically necessary every 5 years)
- Colonoscopy (considered medically necessary every 10 years)
- Guaiac-based fecal occult blood testing (FOBT) (considered medically necessary annually)

Routine screenings are covered at 100% when performed by an in-network provider.

High Risk Screening

Alliant considers colorectal cancer screening with sigmoidoscopy, DCBE, or colonoscopy a Medically Necessary preventive service as frequently as every two-years and FOBT annually for members 18 years or older with any of the following risk factors:

- Personal or family history of colorectal cancer
- Personal or family history of colonic polyps
- Diagnosis of inflammatory bowel disease (including ulcerative colitis or Crohn's disease)
- Genetic susceptibility to malignant neoplasm

High Risk Screenings are covered at 100% when performed by an in-network provider.

Diagnostic Testing

Alliant considers diagnostic testing with sigmoidoscopy, DCBE, colonoscopy and/or FOBT as medically necessary for evaluation of members with signs or symptoms of colorectal cancer or other gastrointestinal diseases.
