What is the overall <u>deductible</u> ? Check your policy or <u>plan</u> document to see when the <u>deductible</u> starts over (usually, but not always, January 1st). Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive</u> <u>care/screening</u> /immunization. Additional details included per service category elsewhere in this SBC.
