TIME TO RENEW FOR 2016

Letters and renewal forms for legacy Individual/Family Plans will be mailed to members on August 1, 2015. We informed members that plan renewal is not automatic. If they would like to keep their current legacy policy, they must renew their plan as is (**no changes allowed**). If accepted, plans would renew on October 1, 2015. In order to complete the renewal process, members must complete, sign and return the renewal form to Alliant by September 15, 2015. SMALL GROUP EARLY RENEWAL OPTION SOON AVAILABLE

Small groups who currently have transitional plans will soon be able to take advantage of the early renewal plan option. Each group will receive their current plan and rate along with the new early renewal rate.

If a group opts for the early renewal option, they will have a renewal date reset to October 1. The early renewal option form will need to be completed and

returned no later than September 1, 2015 to obtain an October 1 effective date. Stay tuned for additional details in a separate email.

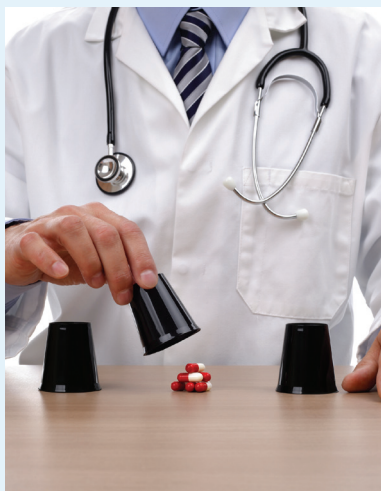

IMPORTANT REMINDERS

- Open Enrollment for individual plans is November 1, 2015 through January 31, 2016.
- Individual members with legacy plans will renew on October 1, 2015. Members who would like to renew their plans must renew their plan as is or their coverage will end. In order to renew, members must return their completed and signed renewal form by September 15, 2015.
- Alliant has filed rates/plans for 2016 but cannot release them until approved by CMS; which is not expected for several months.

FORMULARY CHANGE NOTICES FOR MEMBERS

Please be aware of the following two formulary changes which have taken place. Members have been notified as well.

1) On 7/1/2015, Qvar, Aerospan and Tudorza was removed from each member's formulary. Members currently taking these prescriptions will be able to get them at the current tier until 9/30/2015.

2) On 8/1/2015, Levothyroxine, Levothroid, and Unithroid was removed from each member's formulary. Members currently taking these prescriptions will be able to get them at the current tier until 10/31/2015.

Alliant delegates the formulary to the Navitus Pharmacy & Therapeutics (P&T) Committee. This committee decides the formulary status for each drug. The Navitus P&T Committee is an independent group of health care professionals who

recommends which drugs are on each formulary. The Committee first reviews drugs based on therapeutic value, effectiveness and side effects. They determine which drugs are comparable and then consider cost. The goal is to provide members with the best quality medications at the best value.

Affected members should share this information with his or her prescriber and discuss whether a covered alternative is appropriate. Please note: It is very important for members to continue taking medication until they speak with their prescriber.
